#### TRANSFERING YOUR LOT TO ANOTHER PARTY

If you are wanting to dispose of your lot you CANNOT place a sign that states "LOT FOR SALE", but can advertise as "LOT LEASE for SALE". The CWR Boat Club leases the land from the Alberta Government. You can TRANSFER your lease to a new owner, once approved by the Executive. Contact either the Executive 2nd Vice President or Secretary for the appropriate forms. **NOTE:** Only "**one**" name can appear on the lease. Forms can also be found & downloaded from the

website under General Info/Documents. A transfer fee of \$150.00 will be charged & payable, either by cheque or e-transfer at the time of signing.

#### **GATE CODE**

Has been left the same as last year. It is <u>everyone's</u> responsibility to ensure the gates are locked after entering &/or leaving the park. To lock the combo it is suggested the tumblers be set to the code. Push shackle down all the way & scramble tumblers while maintaining downward pressure. Test by pulling up on the shackle to ensure it is locked. If not—repeat process.

**2020 FALL WALKABOUT:** Members of the executive conducted site inspections during September. Lots with infractions were contacted directly to rectify any non compliance issues identified. Most of the identified infractions consisted of: No fire pit grates / Lack of non combustible material around fire pits or too close to wood structures &/or overhanging vegetation / A few wooden decks or oversized landings were observed.

As a reminder the Fire Department will be conducting an inspection this Spring prior to issuing our Burn Permit. If lots are found to be in non-compliance our Burn Permit may not be granted. We trust everyone will do their part to ensure this does not happed!


