# TRANSFERING YOUR LOT LEASE TO ANOTHER PARTY

If you are wanting to dispose of your lot you CANNOT place a sign that states "LOT FOR SALE", but can advertise as "LOT LEASE for SALE". Only "one" name can appear on the lease. The lessee does not own the lot they only retain the right to the annual lease renewal. Any lot user may sell the right to lease, however, there is no property involved as the land is leased to CWR & then subleased to lot users. The only property involved would be improvements made on the lot (ie: paving blocks, shed, fence, fire pit, trailers, etc). A transfer fee of \$150.00 will be charged, payable, either by cheque or e-transfer at the time of signing. ## **GATE CODE**


Has been left the same as last year.

Test by pulling up on the shackle to ensure it is locked. **If not—repeat process.**
